

**Sands Lifestyle Paiza and Elite Member Exclusive –
“The Legendary Autographed Jersey” Lucky Draw Campaign
Terms and Conditions**

1. Venetian Cotai Limited (the “Company”) is the host of Sands Lifestyle Paiza and Elite Member Exclusive – “The Legendary Autographed Jersey” Lucky Draw Campaign (the “Campaign”).
2. The Campaign will be held from 10:00AM, 6 July 2026 to 11:59PM, 20 July 2026 (the “Campaign Period”).
3. The Campaign is open to all individuals that are 18 years old or above.
4. Method of participation is as follows:
 - a) To be eligible to join the Campaign, guests must be valid members of Sands Lifestyle Digital Membership Program. Guests shall download the Sands Lifestyle App or open the officially certified Sands Lifestyle mini program, register as members, complete mobile number verification, present their original ID/passport and complete the real-name authentication at Sands Lifestyle Counters in order to become valid members (the “Participants”). Screenshots, photographs or printed copies of ID/passport will not be accepted.
 - b) The Campaign is exclusively open to Participants who are valid Sands Lifestyle Paiza or Elite tier members. For the purpose of this clause, Participants’ eligibility for lucky draw entries shall be determined based on their valid membership tier upon the end of the Campaign Period.
 - c) Participants must open Sands Lifestyle App in order to receive the Campaign messages.
 - d) Participants are required to register on the Campaign page in Sands Lifestyle App or Sands Lifestyle WeChat Mini-program by filling in their membership card number to be eligible in the Campaign lucky draw.

 - d) Any forms of manipulation, including the use of third-party platforms, tools, or services.

All employees of Venetian Macau Limited, Venetian Cotai Limited, Venetian Orient Limited and their respective affiliates, as well as the employees and their immediate families of retailers, F&B outlets and service providers at Sands Resorts Macao and the employees of the participating vendors and persons

who are legally banned from the hotel areas at Sands Resort Macao cannot participate in this Campaign. If such case is found, the winner(s) shall be disqualified and prize shall not be granted.

The determination of inappropriate content is in the sole and absolute discretion of the Company.

In the event that a Participant is determined to be ineligible or withdraws from the Campaign, the Company reserves the right to replace such person by selecting Participant in the order of the substitution list of nine (9) Participants, who will be randomly selected at the same time with the winners. If none of the nine (9) Participants in the substitution list is eligible to win the prize, the Campaign will be considered terminated and no further redemption shall be made. The selection of the Participants shall be within the sole and absolute discretion of the Company, whose decisions shall be final.
19. All winners shall be submitted to the Company’s compliance vetting procedures. The Company reserves the right to disqualify any winner who is determined to be a Politically Exposed Person (PEP) or government official with regulatory authority over the Company and its affiliates.

26. Given that Las Vegas Sands Corp. If Participants are on any such restricted party list or is added to such restricted party list during this Campaign, the Company reserves the right to disqualify the winners, and prizes shall not be issued or allowed to be claimed. Participants further undertake to notify the Company immediately if Participants are on or added on to any such restricted list during this Campaign.
