

## **“Sands Lifestyle Welcome Lucky Draw” Terms and Conditions**

1. Venetian Cotai Limited (hereinafter the “Company”) is the host of **“Sands Lifestyle Welcome Lucky Draw”** (the “Campaign”).
2. This Campaign will be held from 10:00AM, 8 October 2025 to 5:00PM, 11 October 2025 (the “Campaign Period”).

- f) Participants who have won the prize will no longer participate in the next round of lucky draw.
4. Prize Redemption:
- a) Winners must redeem their prizes by the redemption deadline.
  - b) Winners who do not redeem prizes before the redemption deadline will be disqualified and have their prizes forfeited.
  - c) Winners must be valid Sands Lifestyle members on the date of prize redemption; otherwise, they will be disqualified and have their prizes forfeited.
  - d) Winners must present valid ID card/passport to complete a one-time verification of identity before redemption.

In addition, Participant also expressly authorizes the Company and its affiliates (“Sands”) to share the Data and with any third party service providers of any Sands’ properties that has entered into a written agreement with Sands that is substantially similar to the Company’s privacy policy. Participant acknowledges that the transfers authorized may constitute an international transfer of personal data and that the different jurisdictions where Sands and third-party service providers are incorporated may have different data privacy laws and protections from the data privacy laws and protections in place in the jurisdiction where the Participant is located. The Company will comply with the applicable requirements under the Laws of the Macao Special Administrative Region on cross-border transfer of personal data, and will implement appropriate safeguards. Participant has the right to view his/her personal data, request additional information about its storage and processing, require any necessary amendments, withdraw the consent herein or simply opt-out from receiving direct marketing materials from the Company. Participant can change, remove or review the information provided anytime by either writing to the Company at Estrada da Baía de Nossa Senhora da Esperança, The Venetian Macao, Executive Offices – L2, Taipa, Macao or by emailing the Company at [privacy@sands.com.mo](mailto:privacy@sands.com.mo). The Data will be retained for as long as legally required and in accordance with the Company data retention and classification policies. The Company takes

appropriate technical and organizational measures to protect Data against unauthorized or unlawful processing, accidental loss, destruction, or damage.

6. Any Participant found cheating, in breach of the laws or in breach of these Terms and Conditions will be banned from the Campaign and made ineligible for prizes. The Company has sole discretion to override the results and disqualify any Participant suspected of fraud, manipulation or other related issues. The Company reserves the right to disqualify Participants for providing false information (including but not limited to, fake account(s), personas or photos) or for deliberately withholding information.
7. Automated submissions via computer modems or any other programs will be deemed invalid. The Company reserves the right in its sole discretion to disqualify any individual who tampers with the submission process, which as a result corrupt or affect the administration security.
8. All employees of Venetian Macau Limited, Venetian Orient Limited and the Company, their affiliates or subsidiaries, as well as employees and their immediate families of the retail outlets at shopping malls and resorts owned by the aforementioned companies and of their participating vendors cannot participate in this Campaign. If such case is found, the winners shall be disqualified and prize shall not be issued.

The determination of inappropriate content is in the sole and absolute discretion of the Company.
11. All winners shall be submitted to the Company's compliance vetting procedures. The Company reserves the right to disqualify any winner who is determined to be a Politically Exposed Person (PEP) or government official with regulatory authority over the Company and its affiliates.
12. Participants may not dissent to the prizes given out by the Company. The prizes may not be transferred, resold, exchanged for cash or other goods.
13. The Company reserves the right to revise, cancel, suspend or modify this Campaign at its sole discretion without notice. At any time, the Company reserves the right to disqualify a Participant, to modify these Terms and Conditions, or any aspect of the Campaign as it deems necessary, or to cancel the production and development of the Campaign. The Company is under no obligation to exploit the Campaign in any media.

Participants represent and warrant that they are currently not on the OFAC List, nor on any similar restricted party listings, including those maintained by other governments pursuant to applicable United Nations, regional or national trade or financial sanctions, nor on the DICJ and/or Internal Barred Patrons List. If Participants are on any such restricted party list or is added to such restricted party list during this Campaign, the Company reserves the right to disqualify the winners, and prizes shall not be issued or allowed to be claimed. Participants further undertake to notify the Company immediately if Participants are on or added on to any such restricted list during this Campaign.
