Shop and Stay

Terms & Conditions

- 1. This promotion is organized by Venetian Cotai Limited ("VCL") and Venetian Orient Limited ("VOL") ("Promotion").
- 2. Subject to the terms and conditions of this Promotion, from 18 July to 16 October 2016 ("Term"), shoppers that are followers of Sands Resorts Cotai Strip Macao WeChat official account spending the aggregate amounts referred to in sub-paragraphs a), b), c), d)and e)of this clause 2, at the shops and kiosks at Shoppes at Four Seasons, Shoppes at Parisian, Shoppes at Venetian and Shoppes at Cotai Central ("Shops") are entitled to the below:

from Monday to Sunday, from 10:00am to 11:00pm.

- 10. Copies, defective, defaced, damaged or tampered receipts, Shop & Stay Vouchers and Dining Vouchers will not be accepted by VCL and VOL.
- 11. Lost, stolen or damaged Shop & Stay Vouchers and Dining Vouchers are not reclaimable, refundable or replaceable by VCL and VOL.
- 12. The redemption of the Shop & Stay Vouchers and Dining Vouchers must be made in person. Employees of the Shops are **NOT** allowed to make redemptions for any customers.
- 13. For redemption of the Shop & Stay Vouchers and Dining Vouchers, shoppers should provide the Organizers their email and contact number, and must also present the respective Identification Document (Government issued ID or Passport) for verification at the Information Counters referred to in clause 9 above. The name of the shopper and the number of the Identification Document will be registered in the Shop & Stay Voucher and Dining Voucher. - 15. The Shop & Stay Voucher can only redeem rooms reserved under "Shop & Stay Offer" Promotion. The Shop & Stay Vouchers cannot be used, redeemed or refunded for any other packages or hotel rates program being offered.

- 20. The room reservation must be made under the name of the individual registered in the Shop & Stay Voucher using the exact same name as in the Identification Document (Passport or Government ID card). The redemption of the hotel rooms must be made in person and the Shop & Stay Voucher must be presented upon check-in and before 11:55pm of the day of stay, together with the Identification Document of the shopper registered in the voucher.
- 21. The rooms redeemed under this Promotion may only be used by the individual named on the Shop & Stay Voucher and by his/her family members and/or guests (together with the shopper) up to the maximum capacity allowed under the Hotel's policy and regulations in force.
