

Swarovski X'mas Promotion

Terms & Conditions

1. This promotion is organized by Venetian Cotai Limited ("VCL") and Venetian Orient Limited ("VOL") ("Promotion").
2. Subject to the terms and conditions of this Promotion, from 3 December 2015 to 6 January 2016 ("Term"), shoppers spending the aggregate amount of MOP6,800 or above at the shops and kiosks at Shoppes at Four Seasons, Shoppes at Venetian and Shoppes at Cotai Central ("Shops") are entitled to redeem **one Swarovski Ornament Gift and one MOP200 Swarovski Shopping Voucher** ("Gift Set").
3. The aggregate amount referred to in clause 2 shall be spent in two different Shops, on the same day, and valid receipts shall be issued to the customers by the Shops.
4. For the redemption of each Gift Set, the shopper shall present on the same date of the purchase at the Information Counters referred to in clause 10 below, the following:
 - a. Two (2) same day valid receipts issued by two (2) different Shops;
 - b. The merchandise purchased that each one of the receipts refers to;
 - c. Valid Identification Document (Government ID card or Passport) of the shopper.
5. For the avoidance of doubts, the shopper must present exactly **2 same-day receipts** from two different Shops on the same day of the purchase, with the aggregate amount referred to in clause 2 above, for redeeming the Gift Set. The **minimum total amount of each receipt must be MOP200 or above**. Receipts from different dates or that are not of the same day of the redemption of the Gift Set shall not be accepted.
6. A maximum of one receipt from restaurants, lounges, café or food court will be accepted out of the two same-day receipts required for the redemption.
7. Persons who are below 18 years of age as at the date of redemption must obtain their parent or guardian's written consent to their participation in, and to the Terms and Conditions of, the Promotion.
8. Credit card sale slips, hand-written or reprinted invoices shall not be accepted for redemption purposes of the Gift Set.

Purchase or any form of spending with gift vouchers from the Shops, Cotai Water Jet ferry tickets, any tickets from CotaiTicketing™, hotels and Cotai Travel are not subject to this Promotion and do not qualify for the redemption of the Gift Set. Bank transactions are also excluded from this Promotion and do not qualify for redemption of the Gift Set.
10. Redemption of the Gift Set shall be made in person from Monday to Sunday (10:00am to 11:00pm) at the following locations:
 - a. Information Counter at Level 2, Shoppes at Four Seasons, near Shop 2810-2811;
 - b. Information Counter at St. Mark's Square, Shoppes at Venetian, near Shop 808 ;
 - c. Information Counter at Lion Square, Shoppes at Venetian, near Shop 203;
 - d. Information Counter at Level 2, Shoppes at Cotai Central, near Shop 2033;
11. Copies, defective, defaced, damaged or tampered receipts will not be accepted by VCL and VOL.
12. Lost, stolen or damaged Gifts and Shopping Vouchers are not reclaimable, refundable or replaceable by VCL , VOL and Swarovski Hong Kong Limited.
13. The redemption of the Gift Set must be made in person. Employees of the Shops are **NOT** allowed to make redemptions for any customers.

14. For redemption of the Gift Set, shoppers must present the respective Identification Document (Government issued ID or Passport) for verification at the Information Counters referred to in clause 10 above. The name of the shopper, the last 4 digits of the respective Identification Document and the receipt serial number will be recorded by VCL and VOL to check duplication of redemption by the shoppers and retained until the end of the term of this Promotion, after which such information will be destroyed. By participating in this Promotion, shoppers authorize VCL and VOL to collect, use, store and process automatically or mechanically the shoppers referred personal information (hereinafter the "Data"), for the said purposes. Furthermore, the shoppers consent to the communication and transfer of such Data to VCL and VOL affiliates' in Macau, as well as to Las Vegas Sands Corp. ("LVSC") in the United States of America, Sands China Ltd. ("SCL") in Hong Kong and Marina Bay Sands ("MBS") in Singapore, or any of its affiliates (collectively "Sands") for the shopper to be provided with more consistent and personalized experiences in accordance with his/hers preferences across Sands properties, and for marketing products or services (including direct marketing). Shoppers have the right to view their Data, request additional information about its storage and processing, require any necessary amendments or refuse or withdraw the consent herein, by sending an email to privacy@sands.com.mo.
15. Owners and employees of the Shops and their immediate families, contractors and their immediate families, employees of VCL and VOL and their immediate families, are **NOT** eligible to participate in this Promotion.
16. The Swarovski Shopping Voucher can only be used in Swarovski stores at Shoppes at Venetian and Shoppes at Cotai Central.
17. A minimum of MOP2,000 must be spent in Swarovski to use the Shopping Voucher.
18. Only one Shopping Voucher can be used per transaction.
19. The Swarovski Shopping Voucher must be used before the date indicated on the voucher.
20. Each shopper can only redeem **three Gift Sets** throughout the term of the Promotion.
21. The Gift Sets are available on first-come-first-serve basis, while stocks last.
22. The Gift Sets cannot be redeemed for cash value, changed or exchanged for other items.
23. This Promotion cannot be redeemed in conjunction with other promotions and/or privileges.
24. This Promotion can be removed from the marketplace at any time at the discretion of VCL and VOL and the consumer spend on that day will not be entitled to redeem the Gift Set.

Participants acknowledge that Las Vegas Sands Corporation (LVSC), ultimate mother company of the Organizers, is headquartered in the United States of America and that any hotels operating under the LVSC portfolio of brands are legally restricted from conducting business with any persons or entities that are designated on the U.S. Department of the Treasury's Office of Foreign Assets Control (OFAC) List of Specially Designated Nationals and Other Blocked Persons (including terrorists and narcotics traffickers) (the "OFAC List"), since LVSC and affiliates could be determined to have derived income, directly or indirectly, from any such prohibited business activities. Participants represent and warrant that they are currently not on the OFAC List, nor on any similar restricted party listings, including those maintained by other governments pursuant to applicable United

Nations, regional or national trade or financial sanctions, nor on the DICJ and/or Internal Barred Patrons' List. Participants on any such list or that are added to such a list during this Contest, are not eligible to participate in the Promotion or shall be disqualified and the Organizers reserve the right to not issue or allow the prizes to be claimed. Participants shall notify the Organizers immediately if are on or are added to any of such lists during the term of this Promotion.
