

“NBA China Games 2026 Experience Package Presented by Sands Lifestyle” Terms and Conditions

Accommodation Date Range

Hall of Fame Package (Londoner Court, Knightsbridge Suite):

- October 9 and 10, accommodation for two (2) nights (watch Game 1 and Fan Day) or
- October 10 and 11, accommodation for two (2) nights (watch Fan Day and Game 2).

MVP Package (Londoner Paiza Grand, Grand Henry/Grand Catherine Suite) / All-Star Package (The Londoner Hotel, Louis/Victoria Suite or Londoner Grand, Charles/Elizabeth Suite) / Rookie Package (Londoner Grand, Deluxe / Superior Room or Conrad Macao, Deluxe Room):

- October 9, accommodation for one (1) night (watch Game 1 and Fan Day) or
- October 10, accommodation for one (1) night (watch Fan Day and Game 2).

NBA China Games and Fan Day Tickets

All the experience packages include NBA China Games and Fan Day tickets, with details as listed below:

Hall of Fame Package includes two (2) VVIP Courtside Seats for NBA China Games, two (2) VVIP Courtside Seats for Fan Day;

MVP Package includes two (2) VIP tickets for NBA China Games, two (2) VIP tickets for Fan Day;

All-Star Package includes one (1) A-Reserved ticket for NBA China Games, one (1) VIP ticket for Fan Day;

Rookie Package includes one (1) B-Reserved ticket for NBA China Games, one (1) VIP ticket for Fan Day.

Package Booking

At least one (1) adult guest's name and personal information must be submitted at the time of booking.

Venetian Cotai Limited and Venetian Orient Limited (individually and collectively, “Company”) reserve the right to correct the price or cancel the booking if a package is booked at an erroneously published price. Company will contact the guest directly to correct the price or cancel the booking.

Name changes are not permitted after booking confirmation.

Ticket Usage

Tickets for the NBA China Games and NBA Fan Day will be distributed at the hotel front desk upon check-in.

This ticket may not, without the prior written consent of Company, be resold or offered for resale at a premium (including via on-line auction sites) or use for advertising, promotion or other commercial purposes (including market competitions and trade promotions) or to enhance the demand for other goods or services, either by the original purchaser or any subsequent ticket holder. If a ticket is sold or used in breach of this term, the ticket may be cancelled without any refund and the ticket holder may be refused for admission. Entry may be refused if tickets are damaged, defaced, forged or copied in any way or are not purchased from Company official means or other authorized points of sale.

Event Admission

Company reserves the right of admission of ticket holder and all ticket holders are subject to Company's or venue's Conditions of Entry, available at www.CotaiTicketing.com. Late arrival may result in non-admittance until a suitable break in the event.

Cameras, audio and video recorders are not permitted inside the venue, unless previously authorized by Company and NBA China. Company and NBA China reserve the right to broadcast or telecast any event.

Post-Game On-Court Photo with NBA Legend

Guests who purchased a package with benefit of Post-Game On-Court Photo with NBA Legend, will receive an access pass (e.g., wristband) provided by Company before the game. After the NBA China Game, staff will guide the guests to the court for photos in separate groups. Grouping is subject to actual arrangements; individual photos are not guaranteed.

Company will provide a professional photographer for the photoshoot. Guests are prohibited from taking their own photos or selfies with the legends. Legends attending are subject to the final decision of the event organizer and may differ between games.

Identity verification is required for entry. This benefit is non-transferable and non-resalable.

Dinner with NBA Legend

Guests who purchased a package with exclusive benefit of Dinner with NBA Legend, will receive an access pass upon hotel check-in.

The dinner is tentatively scheduled for October 10 at Chiado, lasting approximately 90 minutes. Specific time, location, seating arrangements and attending legend are subject to the final decision of the event organizer.

Identity verification is required for entry. This benefit is non-transferable and non-resalable.

Any additional ordered food or beverages (outside the provided menu) will incur extra charges.

Dietary restrictions must be communicated at least two (2) days prior to the dinner; the restaurant will contact the guests for details.

NBA China Games Behind-the-Scenes Tour

Guests who purchased a package with benefit of NBA China Games Behind-the-Scenes Tour, will receive an access pass (e.g., wristband) provided by Company before the tour.

The tentative Behind-the-Scenes tour schedule is October 10 afternoon (for Game 1 attendees) and October 11 afternoon (for Game 2 attendees). The specific tour schedule and route is subject to the Company's final confirmation.

NBA China Games Gift Bag

Guests must customize or redeem this gift bag at designated location (e.g., NBA Flagship Store) by using the voucher received during check-in. Specific redemption time and location will be informed by staff prior to check-in.

Limo Services

Guests who purchased a package with benefit of Limo services, may enjoy two (2) complimentary one-way transfers within Macao (e.g., between hotel and airport/ferry terminal/border checkpoint).

Guests must inform the hotel of their specific transfer requirements at least three (3) days in advance. The hotel transportation team will notify guests the dispatch details 30 minutes before departure.

Cancellation Policy

Full payment is required at the time of booking. Bookings are non-cancellable, non-changeable, non-transferable, and non-refundable.

Privacy Information

By booking and purchasing any package, guest hereby expressly acknowledges and provides consent for his/her personal data be collected, used, and shared as described herein and in the Privacy Notice. Guest authorizes the Company to collect, use, store and process, automatically or manually, the personal data he/she provides the Company during his/her purchase (including names, ID numbers, telephone numbers and any data related with his/her purchase) (hereinafter the "Data"), for the purposes of the processing

and managing your reservations, promotion and for direct marketing purposes (in respect of the Company's news, promotions and other services), to improve database segmentation and customization of marketing offers, for market research around consumer preferences and to conduct statistical and satisfaction surveys. In addition, guest also expressly authorizes the Company and its affiliates ("Sands") to share the Data and with any third party service providers of any Sands' properties that has entered into a written agreement with Sands that is substantially similar to the Company's privacy policy, so that guest may be provided with more consistent and personalized experiences across Sands' properties. The Company will comply with the applicable requirements under the Laws of the Macao Special Administrative Region on cross-border transfer of personal data, and will implement appropriate safeguards. Guest has the right to view his/her personal data, request additional information about its storage and processing, require any necessary amendments, withdraw the consent herein or simply opt-out from receiving direct marketing materials from the Company. Guest can cease receiving such commercial and marketing communications, or to change, remove or review the information provided anytime by either writing to the Company at Estrada da Baía de Nossa Senhora da Esperança, The Venetian Macao, Executive Offices – L2, Taipa, Macao or by emailing the Company at privacy@sands.com.mo. The Data will be retained for as long as legally required and in accordance with the Company data retention and classification policies. The Company takes appropriate technical and organizational measures to protect Data against unauthorized or unlawful processing, accidental loss, destruction, or damage.

Guest further provides explicit consent for Sands to record videos and take photographs during NBA China Games 2026 Experience, and to use, reproduce, and incorporate guest's image, likeness, voice, and other identifiable characteristics in marketing, promotional, and corporate materials. Such materials may be published or disseminated through various channels, including but not limited to press releases, print publications, websites, blogs, television, video-sharing platforms, and social media channels operated by or on behalf of Sands. I grant Sands, its service providers, and legal representatives a perpetual, worldwide, royalty-free right and permission to capture, use, edit, reproduce, publish, and republish photographic images, video recordings, and/or audio recordings of the guest (or the minor on whose behalf the guest has given consent), in whole or in part, in any format or media, whether now known or hereafter developed, for legitimate business purposes including, without limitation, advertising, marketing, corporate communications, and promotional activities. To the extent permitted by applicable law, guest waives any right to inspect or approve the final materials incorporating such images, recordings, or content. Guest further releases and agrees to hold harmless both the Sands, its service providers and legal representatives, and authorized agents from any claims, demands, or liabilities arising out of or in connection with the creation, use, or

publication of such materials, including (without limitation) claims relating to defamation, infringement of privacy rights, or rights of publicity.

Other Terms:

Unused package benefits cannot be refunded or redeemed for cash or other products or services.

Guest agrees that all benefits in this package are subject to Company's final arrangements, and guests shall not claim any refund or compensation in relation to any change of benefits.

By purchasing or enjoying this package, guest agrees to release, discharge and hold Company and its affiliates harmless from any and all claims including, without limitation, claims for slander, libel, defamation, violation of rights of privacy, publicity, personality, and/or civil rights, depiction in a false light, intentional or negligent infliction of emotional distress, copyright infringement, and/or any other tort and/or damages arising from or in any way relating to the purchase of packages, participation in events, use of benefits and the use of the personal information in connection with this package.

Company reserves the right to change these Terms and Conditions without prior notice. In the event of any dispute, the decision of Company is final without notice or liability. Other Terms and Conditions apply.

The sale of all accommodations, tickets, and services included in the packages shall be governed by the laws of the Macao. Guest also agrees to accept that the courts of Macao shall have exclusive jurisdiction.

By entering to the venue and watching the NBA China Games or NBA Fan Day, photos, videos or any other recordings which capture the ticket holder's image and sound during the NBA China Games and NBA Fan Day will be used for corporate and advertising purposes and in social media and other fan webpages owned or operated by Company or its affiliates and NBA China, to which you expressly consent.

If there is any inconsistency or conflict between the English and Chinese versions of these Terms and Conditions, the English version will prevail.
