

“Autumn Harvest Retreat” Hotel Package Terms & Conditions
Campaign Period: 01 September 2026 - 30 November 2026

General Terms and Conditions

1. The hotel package (“Hotel Package”) is available for two (2) guests upon check-in and is subject to availability.
 - a. The Venetian Macao Hotel Package: One (1) night accommodation in the Royale Deluxe Suite
 - b. The Parisian Macao Hotel Package: Two (2) nights accommodation in the Famille Room
 - c. Londoner Grand Hotel Package: One (1) night accommodation in the Charles Suite
2. For any amendment or cancellation less than forty-eight (48) hours of arrival and/or no-show, a charge equivalent to the Hotel Package price plus applicable service charge and government tax, will be charged from the credit card on file as late cancellation fee.
3. All reservations and check-in must be made during the Campaign Period. The following blackout dates apply: 25-27 Sep 2026, 30 Sep-11 Oct 2026, 16-19 Oct 2026.
4. All rates of Hotel Package are in MOP and subject to 10% service charge and 5% government tax.
5. Any extension of stay after initial booking is confirmed will be subject to availability and hotel flexible rate.
6. At least one (1) occupant of the room must be eighteen (18) years old or above.
7. All guests must be registered upon check-in and present a valid identification card, passport, travel document or other document accepted for migration control purposes, along with a valid stay visa or evidence of being legally allowed to stay in Macau throughout the entire stay in the Hotel (such as Slip of Authorization to Stay).
8. Check-in time is from 3PM, check-out time is up to 11AM.

authorizes the Company to collect, use, store and process, automatically or manually, the personal data he/she provides the Company during his/her participation in this Campaign (including Place of Residence, Title, Name, Phone Number, Email and any data related with his/her participation in this Campaign) (hereinafter the "Data"), for the purposes of hotel reservation, promotion and for direct marketing purposes (in respect of the Company's news, promotions and other services), to improve database segmentation and customization of marketing offers, for market research around consumer preferences and to conduct statistical and satisfaction surveys.
