

澳門康萊德酒店“帶著小熊去旅行2018” Facebook 專頁活動條款與細則
Terms & Conditions – Conrad Macao Travel Bear Facebook Campaign 2018

1. 澳門康萊德酒店“帶著小熊去旅行2018” (“活動”) 由東方威尼斯人有限公司主辦。
活動舉辦日期為: 2018年7月1日至2018年8月31日
Venetian Orient Limited (“VOL”) is the host of “**Conrad Macao Travel Bear 2018 Facebook Campaign**” (“the Campaign”). The Campaign period is 1 July 2018 – 31 August 2018.

2. 本次活動的每位參加者，必須首先成為澳門康萊德酒店Facebook 專頁的粉絲 (<https://www.facebook.com/ConradMacao>)，然後於2018年8月31日晚上11時59分前，把於世界各地地標所影下的澳門康萊德小熊的照片，上載到參加者本人的Facebook 專頁上的生活時報 (Timeline)，參加者必須於帖子上注明 #TravelBear2018 標籤，並且於帖子中標註上 (或@) Conrad Macao, Cotai Central (澳門康萊德酒店) 的Facebook 專頁，同時，帖文設定必須為「公開」。

本次活動將會選出一位得獎者，得獎通知將會在2018年9月10日於澳門康萊德酒店Facebook 專頁公佈，並會於結果公佈當天 (2018年9月10日) 透過Facebook 私信聯絡得獎者。

All participants (“Participants”) must:

3. 得獎者將會跟據以下兩項條件而選出 (總分100%):

Participants represent and warrant that they are currently not on the OFAC List, nor on any similar restricted party listings, including those maintained by other governments pursuant to applicable United Nations, regional or national trade or financial sanctions, nor on the DICJ and/or Internal Barred Patrons List. If Participant is on any such restricted party list or is added to such restricted party list during the term of this Campaign, VOL reserves the right to disqualify the winners, and Grand Prize shall not be issued or allowed to be claimed. Participant further undertakes to notify VOL immediately if Participant is on or added on to any such restricted list during the term of this Campaign.
