

## Conrad Macao Cotai Strip - "2 Days Advance Ferry Package" Terms and Conditions

- 1. This offer is subject to availability.
- 2. All bookings are required to be made at least 2 days prior to arrival.
- 3. All rates are based on Single and/or Double occupancy.
- 4. Bookings must be fully pre-paid upon making reservations.
- 5. Conrad Macao Cotai Strip Cotai Water Jet Ferry Ticket Package inclusions are on a per stay basis, and all must be redeemed before check out.
- 6. No cancellations, refunds, date or name change are allowed after reservation is made. Cancellation of the booking or reduction in the number of nights is not permitted. A charge equivalent to the total room rental price plus service charge and government tax will be imposed for no-show.
- 7. Cost for an additional guest (12 years old or below) is HKD/MOP200 per person per night inclusive of round-trip ferry tickets.
- 8. Cost for an additional guest (13 years old or above) is HKD/MOP350 per person per night inclusive of round-trip ferry tickets.
- 9. The Conrad Macao and Venetian Cotai Limited reserves the right to release the rooms for resale without prior notice if the credit card is invalid.
- 10. Rates are based upon your length of stay. If you alter your arrival or departure dates, rates are subject to change.
- 11. Any extension or amendment of stay after initial booking is confirmed, will be subject to availability and will be at hotel's Best Available Rate.

## **Cotai Water Jet**

General rules for Cotai Water Jet ticket redemption:

- Ferry tickets from Hong Kong to Macao: Guest is required to approach Cotai Water Jet ticketing counters of Hong Kong Macao Ferry Terminal (located at Sheung Wan) and present personal ID / Passport (original copy) for ticket redemption process. Ticket redemption is available only on hotel check-in date of the purchased package.
- 2. <u>Ferry tickets from Macao to Hong Kong</u>: Complimentary Cotai Water Jet ferry ticket(s) redemption (Macao to Hong Kong City Route) is available at hotel concierges or CotaiTravel<sup>™</sup> or any designated counters on your arrival date till departure within the property. Redemption must be made before check out, departure date of the ferry tickets must be within 7 days.
- 3. Redemption of complimentary Cotai Water Jet ticket(s) is limited to Cotai Class, between Macau to Hong Kong city route only.



- 4. No prior reservation is allowed for any complimentary ferry ticket(s) and it is subject to schedule and space availability at time of redemption.
- 5. For any advance paid or complimentary Cotai Water Jet ferry ticket(s) or tickets issued by other ferry operators, Cotai Water Jet will not be responsible for any form of full or partial reimbursement or refund.

- 3. Daily sailing schedule from Hong Kong to Macao is conducted at 7:00am and last sailing schedule is 11:00pm. Sailing schedule is subject to changes and availabilities.
- 4. After guest's arrival and checking in, unused ferry tickets (HK-MO) shall not be compensated and refundable.
