# **TERMS & CONDITIONS** BOC Sands Lifestyle UnionPay Credit Card Double Rewards

The BOC Sands Lifestyle UnionPay Credit Card Double Rewards Campaign ("Campaign") is hosted by Venetian Cotai Limited ("VCL") and Bank of China Limited, Macau Branch ("BOC Macau"). These terms and conditions ("T&C") govern the Campaign.

## **CAMPAIGN PERIOD**

From 1 January 2023 to 28 February 2023

#### ELIGIBILITY

Participants must be 18 years old or above and is an eligible BOC Sands Lifestyle UnionPay (Diamond & Black Diamond) Credit Card Cardholder ("Cardholders"). Participants must be valid followers of The Venetian Macao WeChat official account in order to participate in the Campaign.

## CAMPAIGN OFFERS

## Offer 1: Retailer Exclusive Offer

Eligible Cardholders can enjoy one (1) exclusive retail offer at <u>selected Sands Lifestyle participating retailers</u> upon specific spend with their physical BOC Sands Lifestyle UnionPay Credit Card. The exclusive retail offers shall be subject to respective terms and conditions of each designated retailer, please refer to Campaign promotion website for more details.

# MOP100 Rewards Dollar Voucher Redemption

- 1. To redeem the Rewards Dollar Voucher, Cardholders shall present the following documents on the date of purchase at VCL's redemption counters as set out in item 5:
  - One (1) on-day valid sales receipt from the designated Sands Lifestyle participating retailer or restaurant at The Venetian Macao, The Parisian Macao, The Londoner Macao and The Plaza Macao (hereafter, the "Merchants"), and one (1) corresponding BOC Sands Lifestyle UnionPay credit card receipt (with credit card last 4-digits shown) (collectively, the "Receipt").
  - II. The purchased merchandise to which Receipt refers to (except for purchase of services);
  - III. Present a valid BOC Sands Lifestyle UnionPay Credit Card;
  - IV. Cardholder's valid identification documents (Government ID card or passport);
  - V. Unique shopper ID generated by following The Venetian Macao's official WeChat account;
- 2. A copy of the Receipt will be recorded by VCL for audit purpose. The Receipt will be stamped as an indication of the completion of the Rewards Dollar Voucher redemption;
- 3. Each eligible receipt can only be used once for redemption;
- 4. The redemption is subject to availability and on a first-come-first-serve basis.

- 6. Each Cardholder is limited to a total of three (3) redemptions (regardless of the total value) throughout the promotion period; if a cardholder opts for all 3 redemptions on the same day, cardholder must present 3 eligible on-day spending receipts and corresponding credit card receipts to be eligible.
- 7. The collection of the Rewards Dollar Voucher must be made in person by the Cardholder. Employees of the Shops are NOT allowed to collect on behalf of the cardholders;
- 8. The minimum amount of each Receipt shall be MOP2,000; Receipts of less than MOP2,000 or that are not of the same day of the collection of the Rewards Dollar Voucher, do not qualify for this Campaign and will not be accepted;
- Purchased merchandise of each designated Sands Lifestyle Merchant should be presented on one (1) receipt with its total amount. Any split receipts for the same merchandise will not be accepted for Campaign redemption;
- Receipts issued after 9:00pm will be accepted for redemption of the Rewards Dollar Voucher on the next day (with exception to receipts from 28<sup>th</sup> February 2023 which will need to be redeemed before 11:00pm);
- 11. Purchases of gift vouchers at Merchants, pre-order deposit receipts from Merchants, top-up receipts from Merchants are not subject to this Campaign and do not qualify for the redemption of the Rewards Dollar Voucher. Digital bank transactions and digital receipts are also excluded from this Campaign and do not qualify for redemption of the Rewards Dollar Voucher;
- 12. Receipts priced in Hong Kong Dollar (HKD) or Chinese Yuan Renminbi (RMB) will be considered as 1:1 rate with Macau Pataca (MOP) under this Campaign;
- 13. Redeemed Receipts from restaurants cannot be refunded or exchanged. The purchased merchandise presented on redeemed Receipts from retailers cannot be refunded, but exchanged only. All exchanges of purchased products will be subject to the exchange policy and regulations of the Retailers.
- 14. Hand-written, E-receipts or reprinted invoices are not accepted for the purposes of this Campaign;
- 15. Copies, defective, defaced, damaged or tampered receipts will not be accepted by the Company for redemption under this Campaign;

- b) The Rewards Dollar Vouchers must be used on or before the expiry date stated on the Rewards Dollar Vouchers. The validity period of the Rewards Dollar Vouchers will not be extended for any reason, including but not limited to travel restrictions resulting from Covid-19 measures.
- c) All Rewards Dollar Vouchers are non-transferable, non-refundable, and non-redeemable for cash or any other products or services, and cannot re-sold to a third party. In the case that a

Rewards Dollar Voucher is deemed as resold, the Rewards Dollar Voucher will be considered null and void and the Shopper will no longer be qualified for future redemptions.

- d) Any Rewards Dollar Vouchers that have been mutilated, altered, copied, hand printed, forged, water damaged, manipulated or tampered with in any way, or that contain any computer programming, printing, mechanical or typographical error will be considered null and void.
- e) Lost, stolen or damaged Rewards Dollar Vouchers are not reclaimable, refundable or replaceable.
- f) If value of purchase(s) is less than the face value of the Rewards Dollar Voucher, no change will be provided.
- g) The Rewards Dollar Vouchers issued under this Campaign may be used in conjunction with other kinds of rewards dollar vouchers issued by other concurrent campaign and will be subject to the terms & conditions as listed on the respective vouchers.

#### **CAMPAIGN TERMS & CONDITIONS**

- 1. VCL and BOC Macau reserves the right at its absolute discretion to vary, delete or add to any of these Terms and Conditions at any time.
- 2. VCL reserves the right to cancel, terminate or suspend this promotion at any time. For the avoidance of doubt, cancellation, termination or suspension by VCL of this promotion shall not entitle the Eligible Cardholder to any claim or compensation against VCL for any and all losses or damages suffered or incurred by the Eligible Cardholder as a direct or indirect result of the act of cancellation, termination or suspension.
- 3. The Eligible Cardholder shall be personally responsible for all taxes, rates, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to this promotion.
- 4. VCL's decision on all matters relating to this promotion shall be final and binding.
- 5. Failure to adhere to these Terms and Conditions may result in disqualification.
- 6. The English version of these Terms and Conditions shall prevail wherever there is a discrepancy between the English and the Chinese versions.

Personal Data: We collect the personal data you provide us (including but not limited to your name, your BOC Sands Lifestyle UnionPay card last four digits, your WeChat ID, your telephone number, and any data related with your participation in this Campaign) for the purposes of this Campaign and, in order for you to redeem the Campaign Offer we also ask you to present us your Identification Document (Government ID or Passport) and BOC Sands Lifestyle UnionPay card. We also collect your data for direct marketing purposes (in respect of our news, campaigns, and other services), to improve database segmentation and customization of marketing offers, for market research around consumer preferences and to conduct statistical and satisfaction surveys. We will record the last 4 digits of your Identification Document (Government ID or Passport) to verify and mislead potential duplication of redemptions and we will keep them during your participation in the Campaign after which we will destroy them. At any time you have the right to view your personal data, request additional information about its storage and processing, require any necessary amendments, and withdraw the consent herein or simply opt-out from receiving direct marketing materials from us by emailing us at privacy@sands.com.mo.

By participating in this Campaign, you hereby authorize the VCL to collect, use, store and process automatically or mechanically any personal data provided by you (hereinafter the "Data"), for the said purposes, including your name, your BOC Sands Lifestyle UnionPay card last four digits, your WeChat ID, your telephone number, and any data related with your participation in this Campaign. You also authorize the VCL to use your Data for direct marketing purposes (in respect of our news, campaigns, and other services), to improve database segmentation and customization of marketing offers, for market research around consumer preferences and to conduct statistical and satisfaction surveys. No marketing offers should be sent to you in the Mainland People's Republic of China. In addition, you expressly authorize the VCL to share and disclose, in confidentiality, your Data with Las Vegas Sands Corp. ("LVSC") in the United States of America, Sands China Ltd. ("SCL") in Hong Kong and Marina Bay Sands ("MBS") in Singapore, or with any of its affiliates (collectively "Sands") and with any third-party service providers as may be currently used or selected by any of Sands properties in the future, which have entered into an agreement with Sands that is substantially similar to Sands Privacy Policy, for the above said purposes and so that you may be provided with more consistent and personalized experiences across Sands' properties.

You acknowledge that the transfers hereby authorized may constitute an international transfer of personal data and that the different jurisdictions where the VCL, LVSC, SCL and MBS affiliates and third-party service providers are incorporated may have different data privacy laws and protections. You further declare that you were given the opportunity to make queries and request clarifications on the above and that you have obtained complete and proper answers and clarifications.

9. OFAC List: Cardholders acknowledge that Las Vegas Sands Corp. (LVSC), ultimate mother company of the VCL, is headquartered in the United States of America and that any hotels operating under the LVSC portfolio of brands are legally restricted from conducting business with any persons or entities that are designated on the U.S. Department of the Treasury's Office of Foreign Assets Control (OFAC) List of Specially Designated Nationals and Other Blocked Persons (including terrorists and narcotics traffickers) (the "OFAC List"), since LVSC and affiliates could be determined to have derived income, directly or indirectly, from any such prohibited business activities. The OFAC List can be found by visiting https://home.treasury.gov/policy-issues/financialsanctions/specially-designated-nationals-and-blocked-persons-list-sdn-human-readable-lists. Cardholders represent and warrant that they are currently not on the OFAC List, nor on any similar restricted party listings, including those maintained by other governments pursuant to applicable United Nations, regional or national trade or financial sanctions, nor on the DICJ and/or Internal Barred Patrons' List. Cardholders on any such list or that are added to such a list during this Campaign, are not eligible to participate in the Campaign or shall be disqualified and the VCL reserves the right to not issue or allow the prizes to be claimed. Cardholders shall notify the VCL immediately if they are on or are added to any of such lists during the Term of this Campaign.
