# BOC Sands Lifestyle Credit Card \_Local Spending Offer ("Campaign")


#### **CAMPAIGN PERIOD**

Campaign Period: 01 May to 31 July, 2025 (both dates inclusive)

Redemption Period: 01 June to 30 September, 2025 (both dates inclusive)

#### **ELIGIBILITY**

1. This Campaign is open to all valid BOC Sands Lifestyle UnionPay Credit Cards ("Participating Cards"):





- a. Both principal and supplementary cardholders of Participating Cards are qualified for this Campaign, accumulated spend will be calculated separately.
- b. New sign-up cardholders of Participating Cards can only join this Campaign after three months of card activation\*;
- \*Note: Date of card activation is counted from the day the Cardholder calls BOC hotline to active the Participating Cards.

(collectively, the "Eligible Cardholder(s)")

- 2. The Eligible Cardholder must make eligible spend transaction(s) up to the stipulated amount within each month during the Campaign Period to be eligible to join this Campaign.
- 3. All transactions must be settled with the physical Participating Cards or e-Payment such as UnionPay QR code and Apple Pay. Any tax payment, government charges, cash withdrawal, BOC Macau App QR code payment through Participating Cards, bus fare or other transaction criteria that will be announced irregularly, are ineligible for this Campaign.

- 3. Eligible Cardholder shall click the hyperlink provided in in-app notification for redeeming e-voucher (contains one-time scannable QR code). E-voucher is limited in quantity and on a first-come, first served basis while stocks last.
- 4. The hyperlink will be valid for redemption within the month of in-app notification received and will not be re-issued once expired.
- 5. Eligible Cardholder for this Offer will not be eligible for any other campaigns offered by Sands Lifestyle Program during the Campaign Period.

# **MOP300 Rewards Dollar**

- 1. BOC Macau App will send an in-app notification with hyperlink to Eligible Cardholders for e-voucher redemption.
- 2. To redeem Rewards Dollar, Eligible Cardholders must present the redeemed e-voucher, corresponding Participating Cards and a matching valid photo ID at any Sands Lifestyle Counter locations below:
  - o The Venetian Macao St. Mark's Square, Shoppes at Venetian, near Shop 808
  - o The Parisian Macao Level 5, Shoppes at Parisian, near Shop 517a
  - o The Londoner Macao Level 2, Shoppes at Londoner, near Shop 2016

- 3. Rewards Dollar must be redeemed within one (1) month upon successful redemption of e-voucher via BOC Macau App. Rewards Dollar must be used within seven (7) days after the redemption date.
- 4. Rewards Dollar can be used at any participating outlets including Cotai Ticketing, Cotai Travel, Sands Guests Service and all participating retailers, restaurants and bars within Sands Resorts Macao, please refer to the full list for more details.

  - V Spa, The Venetian Macao.
- 4. Within the redemption month, only one (1) redemption can be used. and the SPA Credit only applies to a la carte Spa treatments service priced MOP1,200 and above.
- 5. To enjoy the offer, transaction must be fully settled with valid BOC Sands Lifestyle UnionPay Credit Card.
