



## ICBC Sands Lifestyle Mastercard - Culinary Journey Campaign Terms and Conditions

### TERMS AND CONDITIONS

During the Campaign Period, cardholders ("Cardholders") of valid ICBC Sands Lifestyle Mastercard ("Credit Card") can enjoy a variety of dining promotions within Sands Resorts Macao.

#### Promotion: MOP 100 Rewards Dollar Redemption

- Spending Period and Redemption Period: Now until 9 August, 2026
1. During the Spending Period and Redemption Period, Cardholders who spend MOP500 or above in a single transaction (total amount after discount and inclusive of service charge) with ICBC Sands Lifestyle Mastercard issued by ICBC (Macao) with physical card payment transaction at the participating restaurants, are eligible to redeem MOP100 Rewards Dollar ("Rewards Dollar") at designated Sands Lifestyle counter.

Receipts issued after 9:00PM will be accepted for redemption on the next day

  6. Each Cardholder can redeem a maximum of two (2) Rewards Dollars per day. Last four (4) digits of Credit Card number will be recorded to avoid duplicated redemption.

Cardholder has the right to view his/her personal data, request additional information about its storage and processing, require any necessary amendments. The Data will be retained for as long as legally required and in accordance with Sands' data retention and classification policies. Sands takes appropriate technical and organizational measures to protect Data against unauthorized or unlawful processing, accidental loss, destruction, or damage.
