

SANDS LIFESTYLE INTRODUCTORY OFFER TERMS & CONDITIONS

Offer Details

ICBC Sands Lifestyle Mastercard Platinum and World cardholders will receive the Introductory Offers for spend level reached within their first three months. The three month period is counted from the date of card activation/pick up for applicants in Macao and date of card activation for applicants in Hong Kong. An email with the voucher codes will be sent to cardholder's registered email address upon fulfillment of spending requirement.

Offer period (applicants in Hong Kong): This Introductory Offer is valid for all members who activate their card from April 1, 2019 to December 31, 2019.

Upon reaching the minimum spend of **HKD/MOP 18,000** within the first three months, members can earn the following Introductory Offer:
