

# TERMS & CONDITIONS

## Sands Lifestyle Welcome Offer

1. The BOC Sands Lifestyle UnionPay Credit Card is a co-branded credit card loyalty program of Sands China Limited (“SCL”) in collaboration with Bank of China Limited, Macau Branch (“BOC Macau”). The Sands Lifestyle Welcome Offer (“Campaign”) is a Sands Lifestyle Loyalty Program (“Sands Lifestyle”) campaign for BOC Sands Lifestyle UnionPay Credit Card Cardholders (“BOC Cardholders”). By participating in this Campaign, Cardholders are deemed to have accepted this Campaign Terms & Conditions (“Campaign T&Cs”) and Sands Lifestyle Program Terms & Conditions (“Program T&Cs”).

### CAMPAIGN PERIOD

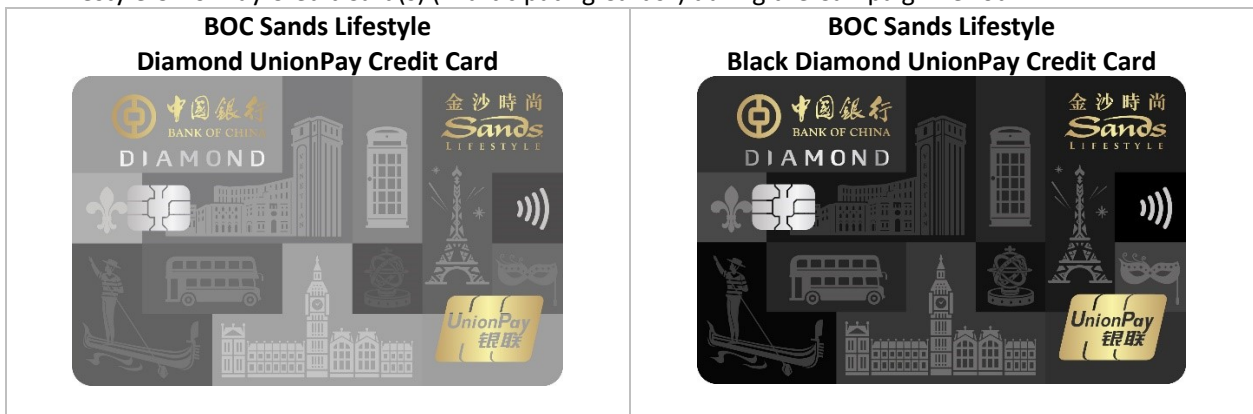
2. The following periods (“Campaign Period”) are applicable for this Campaign:
  - a. Card Application Period: October 27, 2021 to December 31, 2021;
  - b. Spend Period:  
Welcome Offer 1: 2 months from the Date of Card Activation  
Welcome Offer 2: 3 months from the Date of Card Activation

Note: Date of Card Activation is counted from the day the cardholder calls BOC hotline to activate the BOC Sands Lifestyle UnionPay Credit Card. Cardholder must activate his/her BOC Sands Lifestyle UnionPay card within 3 months, otherwise he/she will be disqualified for the Welcome Offer.

3. Card Application is limited to BOC Macau branches in Macau SAR only.

### ELIGIBILITY

4. This Campaign is open to any individual<sup>^</sup> who applies and activates any one of the following BOC Sands Lifestyle UnionPay Credit Card(s) (“Participating Cards”) during the Campaign Period:



- a. Both principal and supplementary cardholders are qualified for this Campaign.

<sup>^</sup>Refers to any individual who has never owned any BOC Sands Lifestyle UnionPay Credit Card(s) or participated in this welcome offer campaigns in the past prior to the date of application for BOC Sands Lifestyle UnionPay Credit Card.

(collectively, the “Eligible Cardholder”)

5. The Eligible Cardholder must make eligible spend transaction(s) up to the stipulated amount within the Spend Period to qualify for the Welcome Offer.

### CAMPAIGN OFFERS

6. There are two (2) separate Welcome Offers under this Campaign. Each offer has its own Spend Criterion to be fulfilled as detailed below:

### CAMPAIGN TERMS & CONDITIONS

7. Eligible Cardholders can enjoy both Tier 1 and Tier 2 offers if he/she meets both Spend Criteria.
8. Upon fulfilling the Eligible Spend Criterion, the Eligible Cardholder will receive a congratulatory SMS notification from BOC Macau, via registered mobile number during card application, within 45 days after fulfill the Spend Requirement.
9. The congratulatory SMS contains a unique redemption code, unique booking link and instructions to redeem the Welcome Offer.
10. The Welcome Offer must be redeemed and booked within three (3) months upon receiving the congratulatory SMS,
11. All unredeemed Welcome Offer exceeding three (3) months from the date of receiving the congratulatory SMS shall be forfeited.
12. During the Promotion Period and at the time of Welcome Offer redemption, the Eligible Cardholder's Participating Card must not be delinquent, closed, and/or invalid/inactive, dormant or cancelled within Sands Lifestyle and BOC Macau's definition. 15. Sands Lifestyle reserves the right at its absolute discretion to vary, delete or add to any of these Terms and Conditions at any time. The amended Terms and Conditions shall prevail over any provisions or representations contained in any other promotional materials advertising this Campaign.
16. Sands Lifestyle may use any of the following modes to communicate notices in relation to this Campaign to the Eligible Cardholder:
  - a. individual notice to the Eligible Cardholder (whether by written notice or via electronic means) sent to the Eligible Cardholder's latest mobile number as maintained in BOC Macau's records;
  - b. press advertisements;
  - c. notice in the Eligible Cardholder's credit card statement(s) or composite statement;

- d. display at its business premises; or
  - e. notice on Sands Lifestyle and/or BOC Macau's website(s).
17. This Campaign T&Cs are in addition to Program T&Cs of which the respective Cardholders are a part of and which regulate the provision of Sands Lifestyle. In the event of inconsistency between this Campaign T&Cs and any of the aforementioned terms and conditions, this Campaign T&Cs shall prevail insofar as they apply to this Campaign.
18. Sands Lifestyle reserves the right to cancel, terminate or suspend this Campaign at any time. For the avoidance of doubt, cancellation, termination or suspension by Sands Lifestyle of this Campaign shall not entitle the Eligible Cardholder to any claim or compensation against Sands Lifestyle for any and all losses or damages suffered or incurred by the Eligible Cardholder as a direct or indirect result of the act of cancellation, termination or suspension.
19. The Eligible Cardholder shall be personally responsible for all taxes, rates, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to this Campaign.
20. Sands Lifestyle's decision on all matters relating to this Campaign shall be final and binding.
21. By participating in this Campaign, the Cardholder agrees to be bound by this Campaign T&Cs and the decisions of Sands Lifestyle.

## **WELCOME OFFER REDEMPTION AND OTHER TERMS & CONDITIONS**

### **1. MOP300 Rewards Dollar Redemption**

- a. BOC Macau will send a congratulatory SMS with a unique redemption code to the Eligible Cardholder.
- b. To redeem the Rewards Dollar, eligible Cardholder must present the redemption code, corresponding BOC Sands Lifestyle UnionPay Credit Card and a matching valid photo ID at any Sands Lifestyle Counter locations below:
  - o The Venetian Macao – St. Mark's Square, Shoppes at Venetian, near Shop 808
  - o The Parisian Macao – Level 5, Shoppes at Parisian, near Shop 517a
  - o The Londoner Macao – Level 2, Shoppes at Londoner, near Shop 2016
- c. Rewards Dollar must be redeemed within three (3) months upon receiving the congratulatory SMS and the Rewards Dollar must be used within seven (7) days after the redemption date.
- d. The Rewards Dollar is non-transferable, non-refundable, and non-redeemable for cash or any other products or services.
- e. Any lost Rewards Dollar cannot be re-issued and are non-refundable.
- f. The Rewards Dollar can be used at any Sands Lifestyle Participating Outlets including Cotai Ticketing, Cotai Travel, Sands Guests Service and participating restaurants within Sands Resorts Macao, please refer to the [full list](#) for more details.
- g. The Rewards Dollar cannot be used in conjunction with any other promotion, discount offers, gift vouchers or cash coupons.
- h. If value of purchase/s is less than the face value of the coupon, no change will be provided.

### **2. One (1) Complimentary Room Night**

- a. BOC Macau will send a congratulatory SMS with booking link to the Eligible Cardholder.
- b. To redeem the hotel stay, the Eligible Cardholder must access the booking link in the congratulatory SMS, verify their phone number, and follow the instructions to book the hotel stay.
- c. The complimentary room night is only valid for stays between Sunday & Thursday each week. Friday & Saturday redemptions are not permitted.
- d. The complimentary room night is subject to availability and blackout dates apply.
- e. The hotel stay must be redeemed, booked & stayed within three (3) months upon receiving the congratulatory SMS.

The corresponding BOC Sands Lifestyle UnionPay credit card must be presented upon check-in, prior to 11:55pm on the stay date.
- n. The complimentary room night redeemed under this promotion may not be resold or transferred. In the case that a room is deemed as resold or transferred, the room will be charged at the hotel's best available rate.
- o. Hotel official check-in and check-out time and all special requests will be subject to hotel availability upon arrival.
