

TERMS AND CONDITIONS

General

- The below listed packages (“Packages”) are subject to maximum guest capacity and availability:
 - Discover the Best of Macao Hotel Package**
- All cancellations or amendments must be made 24 hours before arrival date. A charge equivalent to the total package price plus service charge will be imposed as cancellation charge from credit card on file.
- All reservations are required to guarantee by deposit or credit card during Chinese New Year (21-27 Jan, 2023), Ching Ming Festival (3-4, April, 2023), Easter Holiday (7-10 April, 2023), Labor Day (29 April – 3 May, 2023), Dragon Boat Festival (22-24 June, 2023), no cancellation and amendment is allowed 72 hours prior to the above arrival date. The deposit of the entire stay, tax, and service charge will be imposed 72 hours prior to arrival. A charge equivalent to the total room rental price plus service charge and government tax will be imposed in case of No-Show.
- All rates are in MOP and subject to 10% service charge and 5% government tax.
- Any extension of stay after initial booking is confirmed will be subject to availability and will be at hotel’s flexible rate.
- At least 1 occupant of the room must be 18 years old or above.
- All guests must be registered upon check-in and present a valid identification card, passport, travel document or other document accepted for migration control purposes, along with a valid stay visa or evidence of being legally allowed to stay in Macau throughout the entire stay in the Hotel (such as Slip of Authorization to Stay).
