

TERMS AND CONDITIONS

General

- The below listed packages (“Packages”) are for two guests and subject to availability:
 - The Venetian Macao Romantic City Escape Hotel Package**
 - The Parisian Macao Romantic City Escape Hotel Package**
 - The Londoner Macao Romantic City Escape Hotel Package
(The Londoner Hotel or Conrad Macao)**
- All cancellations or amendments must be made 24 hours before arrival date. A charge equivalent to the total Package price plus service charge will be imposed as cancellation charge from credit card on file.
- All reservations is required to guarantee by deposit or credit card during Ching Ming Festival (03-04 Apr, 2022), Easter Holiday (15-18 Apr, 2022), Labor Day (30 Apr-05 May, 2022), Tung Ng Festival (03-04 Jun, 2022), Mid-Autumn Festival (09-11 Sep, 2022), Chinese National Day (01-07 Oct, 2022), Christmas (23-27 Dec, 2022) and New Year’s Eve (30-31 Dec, 2022), no cancellation and amendment is allowed 72 hours prior to the arrival date.
