

## TERMS AND CONDITIONS

### General Terms and Conditions

1. The below listed package (“Package”) are subject to maximum guest capacity and availability:
  - **2024 Sands China Macao International 10K Hotel Package**
2. All reservations are required to guarantee by deposit or credit card, no cancellation and amendment is allowed prior to the arrival date. The deposit of the entire stay, tax, and service charge will be imposed prior to arrival. A charge equivalent to the total Package price plus service charge and government tax will be imposed in case of cancellation or No-Show from credit card on file.
3. All rates of Package are in MOP and subject to 10% service charge and 5% government tax.
4. Any extension of stay after initial booking is confirmed will be subject to availability and will be charged at hotel’s flexible rate.
5. At least 1 occupant of the room must be 18 years old or above.
6. All guests must be registered upon check-in and present a valid identification card, passport, travel document or other document accepted for migration control purposes, along with a valid stay visa or evidence of being legally allowed to stay in Macau throughout the entire stay in the hotel (such as Slip of Authorization to Stay).
7. All Package benefits during the stay are offered on a per room per stay basis.
8. Unused Package benefits during the stay cannot be reimbursed or redeemed for cash or credit either in full or in part.
9. Additional guest charge is MOP 350 + 10% service charge and 5% government tax per night for any additional guest aged 13 years old or above in selected rooms at The Parisian Macao.

15. Guest hereby expressly acknowledges and provides consent for his/her personal data be collected, used, and shared as described herein and in the Privacy Notice. Guest authorizes Venetian Cotai Limited (the “Company”) to collect, use, store and process, automatically or manually, all personal data he/she provides the Company during his/her participation in this Package (including guest’s name, address, email address, phone number, ID/passport number and any data related with his/her participation in this Package) (hereinafter the “Data”), for the purposes of the promotion and for direct marketing purposes (in respect of the Company’s news, promotions and other services), to improve database segmentation and customization of marketing offers, for market research around consumer preferences and to conduct statistical and satisfaction surveys. Guest acknowledges that the transfers authorized may constitute an international transfer of personal data and that the different jurisdictions where the Company, LVSC, SCL, MBS, affiliates and third-party service providers are incorporated may have different data privacy laws and protections. The Company will comply with the applicable requirements under the Laws of the People’s Republic of China and the Macao Special Administrative Region on cross-border transfer of personal data, and will implement appropriate safeguards. Guest has the right to view his/her personal data, request additional information about its storage and processing, require any necessary amendments, withdraw the consent herein or simply opt-out from receiving direct marketing materials from the Company. Guest can cease receiving such commercial and marketing communications, or to change, remove or review the information provided anytime by either writing to the Company at Estrada da Baía de Nossa Senhora da Esperança, The Venetian Macao, Executive Offices – L2, Taipa, Macao or by emailing the Company at [privacy@sands.com.mo](mailto:privacy@sands.com.mo). Guests’ personal data will be kept during their participation in this Package and for marketing purposes for the period of time that Venetian Macau Limited is a party to the concession contract for the operation of casino games of chance in the Macao Special Administrative Region is in force.

18. In case of dispute, the decision of the Company shall be final.
19. The English version shall prevail when there is a discrepancy between the English and Chinese versions of these Terms and Conditions.
