

**Exclusive Offer for Bank of China (Macau) Visa Credit Card Cardholders
Terms & Conditions**

Campaign Period: 17 April, 2026 - 31 May, 2026

DINING OFFER

1. During the Campaign Period, eligible guests who spend the respective minimum amount in single transaction (exclusive of service charge and other discount/offers) with a valid physical Bank of China (Macau) Visa credit card (“BOCM Visa Card”) at designated F&B outlets will be entitled to an instant discount (“Discount Offer”):
 - Spend at least MOP500 to receive MOP50 discount;

The Data will be retained for as long as legally required and in accordance with the Company data retention and classification policies. The Company takes appropriate technical and organizational measures to protect Data against unauthorized or unlawful processing, accidental loss, destruction, or damage.
