

2019 WeChat Pay Campaign (the “Campaign”)

条款与细则:

- Only participants (“Participants”) with WeChat accounts registered with mainland China ID may participate in the Campaign.

- During the Campaign Period, Participants who spend CNY 100 or above per transaction in selected dining outlets at Sands Resorts Macao and pay with WeChat Pay will receive CNY 10 off instantly (“Instant Discount 1”).
