

“Parisian JinLi Wishing Rewards” H5 Game Terms and Conditions

1. Venetian Macao Limited (hereinafter, “VML”) is the host of “Lucky JinLi Wishing Rewards” H5 Game (the “Campaign”).

In order to participate in the Campaign, all participants (“Participants”) must follow the Sands Resorts Macao official WeChat account and agree that Sands Resorts Macao will collect and process Participants’ related data or information during the Campaign and while using the Service. VML reserves the right to identify each Participant according to the qualified personal WeChat account.
