

## Terms & Conditions: Sands Daily Offer

1. Participants must be 21 years of age or older.
2. Participants must not be on the barred list and must have a valid membership card and be in good standing with Venetian Macau Limited.
3. Invited Sands Rewards Gold, Ruby, Diamond members and APEX members who hold valid Macao ID cards are eligible for this promotion.
