

TERMS AND CONDITIONS

General

1. The 'teamLab SuperNature Macao' Hotel Package ("Package") is subject to availability.
2. Credit card guarantee and advance reservation of at least 24 hours prior to arrival time is required for this Package.
3. All cancellations or amendments must be made 24 hours before arrival. A charge equivalent to the total package price plus service charge and government tax will be imposed as late cancellation charge from credit card on file.
4. All rates are in MOP/HKD and subject to 5% government tax and 10% service charge.
5. Any extension of stay after initial booking is confirmed will be subject to availability and will be at Hotel's Flexible Rate.
6. At least 1 occupant of the room must be 18 years old or above.
7. All Package inclusions are on a per stay basis.
8. Unused Package benefits cannot be reimbursed or redeemed for cash or credit either in full or in part.

teamLab SuperNature Macao

1. 'teamLab SuperNature Macao' ("Exhibition") tickets included in this package is for admission from 10:00 to 22:00, Monday to Sunday.
2. Exhibition is not available every second and fourth Tuesday of each month between March 2020 and December 2020 with details below. Blackout dates subject to change.

3. If the package arrival day falls on Tuesday (i.e. the above blackout dates), hotel package guests are entitled to arrange the admission ticket for access on Wednesday (i.e. one day after blackout day) and the visit must be before hotel check-out.
