

## **Show Postponement, Refund and Subsidy Arrangement for “This is MC 2 LIVE IN MACAU” on Jan. 5**

Due to feeling unwell, and under the advice of doctors, MC Cheung Tin Fu had to postpone his concert on Jan.5, 2025 (Sun) at 7pm, part of his “This is MC 2 LIVE IN MACAU” tour. The concert has now been rescheduled to Feb. 1, 2025 (Sat) at 7pm.

1. People who purchased tickets for the “This is MC 2 LIVE IN MACAU” concert on Jan. 5, 2025 through official ticketing channels (including: Cotai Ticketing, BOOKYAY, Macau Ticket, Damai, Maoyan, MCFC), can attend the replacement concert with the original of the valid intact admission ticket (with ticket stub attached). Admission and seating arrangements will remain the same as indicated on the respective admission ticket. Those who are unable to attend the replacement concert may opt to have a refund from Jan. 8, 2025 to Jan. 15, 2025 at 23:59 (Macao time) through the respective official ticketing channel used (including: Cotai Ticketing, BOOKYAY, Macau Ticket, Damai, Maoyan, MCFC).
2. The organiser will provide a fixed amount transportation subsidy and accommodation subsidy to non-Macao residents who had purchased tickets for the performance on Jan. 5, 2025, capped at MOP 500 each subsidy. Eligible ticketholders can scan the QR code below to view the detailed application process and terms.



3. The refund and fixed-amount transportation and accommodation subsidy scheme is only applicable to the original ticket holders who purchased the “This is MC 2 LIVE IN MACAU” concert tickets on Jan. 5, 2025 through official ticketing channels (including: Cotai Ticketing, BOOKYAY, Macau Ticket, Damai, Maoyan, MCFC). Any resale or transfer of tickets without the company's consent, or the acquisition of tickets through any advertising, promotion or any other commercial means not permitted by the company, will not be the

responsibility of the organiser regarding disputes arising from the refund and subsidy application.

4. Personal information collected from applicants for this refund and subsidy will only be used for the application and refund process.
5. If the applicant is found to submit fake tickets, forged tickets, or any form of falsified documents in any way, the organiser has the right not to accept the application and reserves the right to pursue criminal liability against the relevant persons.
6. The organiser reserves the final right to make all refund and subsidy arrangements mentioned above.
